to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s), the receipt of which is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto Cothran & Darby Builders, Inc., its successors and assigns:

ALL that certain piece, parcel or lot of land with the buildings and improvements thereon, lying and being on the westerly side of Ladyslipper Lane, near the City of Greenville, South Carolina, being known and designated as Lot No. 570 on plat entitled, "Map Four, Section Two, Sugar Creek" as recorded in the R.M.C. Office for Greenville County, SC in Plat Book 8P at Page 62 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the westerly side of Ladyslipper Lane, said pin being the joint front corner of Lot Nos. 569 and 570 and running thence with the common line of said lots N. 66-40 W. 212.15 feet to an iron pin at the joint rear corner of Lot Nos. 569 and 570; thence S. 9-24-08 W. 134.97 feet to an iron pin at the joint rear corner of Lot Nos. 557, 558 and 570; thence with the line of Lot No. 570 and Tract L, S. 46-57-20 E. 95.12 feet to an iron pin at the joint rear corner of Lot Nos. 570 and 571; thence with the common line of said lots N. 64-00 E. 165 feet to an iron pin on the westerly side of Ladyslipper Lane; thence with the westerly side of Ladyslipper Lane, on a curve, the chord of which is N. 1-20 W. 41.73 feet to an iron pin, the point of beginning.
