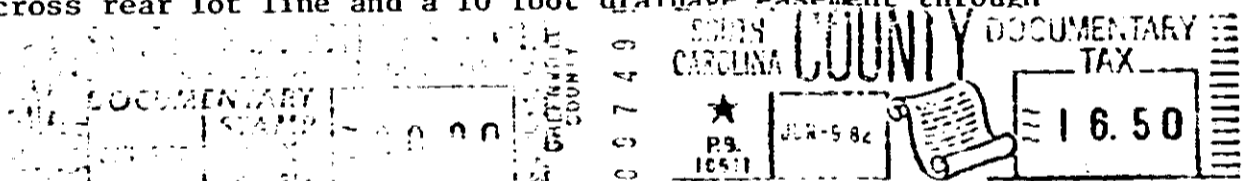
ALL that certain piece, parcel or lot of land with the buildings and improvements thereon, lying and being on the northwesterly side of Woody Creek Road, near the City of Greenville, South Carolina, being known and designated as Lot No. 499 on Plat entitled, "Map One, Section Two, Sugar Creek" as recorded in the R.M.C. Office for Greenville County, SC in Plat Book 7C at Page 68 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the northwesterly side of Woody Creek Road, said pin being the joint front corner of Lot Nos. 498 and 499 and running thence with the common line of said lots N. 57-26 W. 170.19 feet to an iron pin at the joint rear corner of Lot Nos. 498 and 499; thence S. 33-25-28 W. 95.01 feet to an iron pin at the joint rear corner of Lot Nos. 499 and 500; thence with the common line of said lots S. 57-26 E. 171.61 feet to an iron pin on the northwesterly side of Woody Creek Road; thence with the northwesterly side of Woody Creek Road, N. 32-34 E. 95 feet to an iron pin, the point of beginning.
