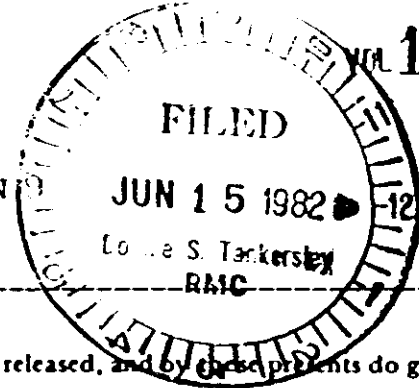

ALL that piece, parcel or lot of land, situate, lying and being in the State of South Carolina, County of Greenville, near the Town of Fountain Inn, containing 3.21 acres, located on Shellstone Drive, as shown on a survey for E. SHALL THACKSTON, JR., prepared by C.O. Riddle, RLS, dated June 2, 1982 and recorded in the RMC Office for Greenville County in Plat Book 6, at page 9-C, and which plat shows the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southern side of Shellstone Drive, at the joint front corner of the within described property and Lot #1, Shellstone Park, and running thence along the joint boundary, S. 21-39 W., 400 feet to an iron pin; thence N. 57-25 W., 350 feet to an iron pin; thence N. 19-02 E., 390.8 feet to an iron pin on the Southern side of Shellstone Drive; thence along the edge of Shellstone Drive, S. 63-45 E., 77 feet to an iron pin; thence S. 58-14 E., 289.2 feet to the point of beginning.
