G. Proffitt, Inc., its successors and assigns, forever:

ALL that certain piece, parcel or lot of land with the buildings and improvements thereon, lying and being at the intersection of Hunting Hill Circle and Cherrywood Trail, near the City of Greenville, South Carolina, being known and designated as Lot No. 544 on plat entitled, "Map Four, Section Two, Sugar Creek" as recorded in the R.M.C.
