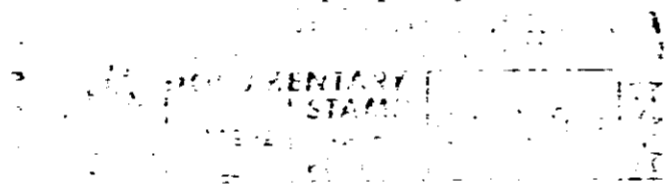

BEGINNING at an iron pin on the westerly side of Ladyslipper Lane, said pin being the joint front corner of Lot Nos. 513 and 514 and running thence with the common line of said lots, N. 71-55 W. 156.23 feet to an iron pin at the joint rear corner of Lot Nos. 513 and 514; thence N. 34-28-06 E. 205.20 feet to an iron pin at the joint rear corner of Lot Nos. 512 and 513; thence with the common line of said lots S. 18-55 E. 196.50 feet to an iron pin on the westerly side of Ladyslipper Lane; thence with the westerly side of Ladyslipper Lane, on a curve, the chord of which is S. 44-35 W. 44.62 feet to an iron pin, the point of beginning.
