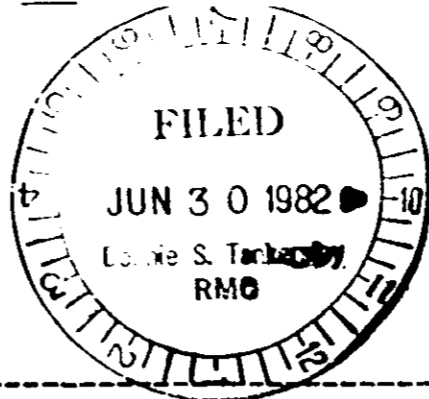

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release  
unto **Michael A. Dorsey, heirs and assigns forever:**

ALL that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, being known and designated as Lot No. 3 on a plat of the lands of Mary E. Page as made by W. J. Riddle, Surveyor, in May 1948, and recorded in R. M. C. Office For Greenville County in Plat Book "T" at Page 46. Said lands lie in School District 160 and are described as follows, by courses, distances, metes and bounds:

BEGINNING at an iron pin on the South Side Of Gordon Street Extension at joint corner of Lots Nos. 2 and 3, which point is 213.7 feet in a Westernly direction from the intersection of Gordon Street Extension and Washington Avenue, and runs thence S. 20-10 E., 133 feet to an iron pin; thence S. 70-28 W., 60 feet to an iron pin at the corner of Lot No. 4; thence with the line of that lot N. 19-50 W., 142 feet to an iron pin on the South Side Of Gordon Street Extension; thence along Gordon Street Extension N. 79-20 E., 60 feet to corner of BEGINNING.

This being the same property conveyed to M. T. Wharton by Miles Wright by deed dated January 31, 1953 and recorded in Deed Book 472 at Page 21, in the R. M. C. Office For Greenville County, South Carolina. Also the same property conveyed to Geneva P. Hice by deed dated September 19th 1972 and recorded in Deed Book 955 at Page 396.
