Frank C. Kramer, Jr. and Susan G. Kramer, their heirs and assigns, forever:

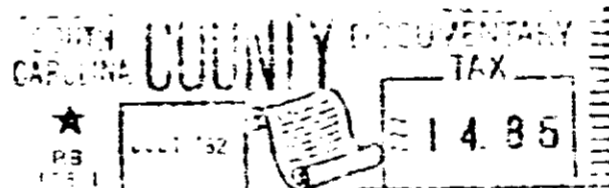
ALL that certain piece, parcel or lot of land situate, lying and being in
