Such parcel of property was intended to have been included in the legal description of property conveyed to Charles B. Minter and Helen F. Minter, predecessors in title to the grantees, by deed recorded in Deed Book 1149 at page 550. It further appears that at the time of the 1974 conveyance by F. W. Yarborough that his interest in the subject property was only a life estate. The subject property is a portion of that lot previously conveyed to the late Anne McGee Yarborough by deed of Julian Calhoum, recorded in Deed Book 623 at page 189. The said Ann McGee Yarborough died testate on January 15, 1965 and devised the subject property to the grantor, Velma Y. Hallman as appears by reference to Apt. 896, File 14 in the Office of Probate Court for Greenville County.
