All my interest in and to all that piece, parcel or lot of land in Greenville County, State of South Carolina, and more specifically designated as being located on the Southeast side of Spartanburg Street (formerly known as Old Spartanburg Road) and beginning at a point on said Spartanburg Street 70 feet from the property designated as Love Property, joint corner of a lot previously sold to Lizzie Chandler Bolden and running thence with the Bolden line, S. 32-21 E. 205 feet to an iron pin; thence N. 51-45 E. 40 feet to an iron pin; thence along line of property formerly belonging to Arthur Black, N. 32-21 W. 205 feet to an iron pin on the Southeast side of Spartanburg Street; thence with said Street, S. 51-45 W. 40 feet to the point of beginning.
