ALL that certain piece, parcel or lot of land with the buildings and improvements thereon, lying and being on the northerly side of Hunting Hill Circle, near the City of Greenville, South Carolina, being known and designated as Lot No. 518 on plat entitled, "Map Four, Section Two, Sugar Creek" as recorded in the R.M.C.
