in consideration of Forty Thousand Nine Hundred Fifty and No/100 (\$40,950.00)-----Dollars,

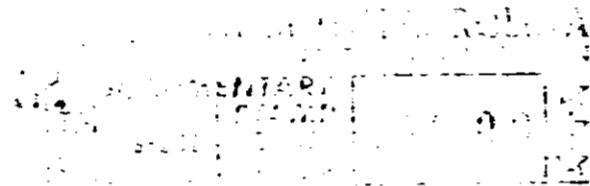
