

Alexander B. Meyers, et al.; thence with the line of said Meyers property, S. 69-24 E. 104.91 feet to a point on the western right of way of Bankers Trust Plaza; thence with the western right of way of Bankers Trust Plaza, S. 22-12 W. 27.9 feet to an iron pin; thence continuing with said right of way, S. 21-09 W. 239.43 feet to the Point of Beginning.
