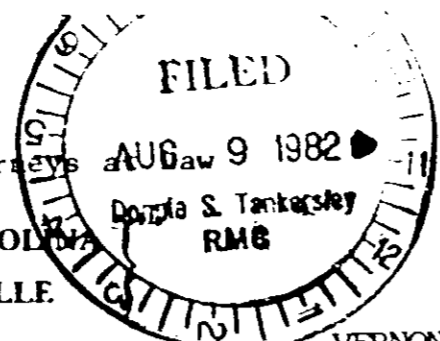

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto HENRY W. JONES and THELMA JONES, their heirs and assigns, forever:

ALL those pieces, parcels or lots of land, with all buildings and improvements thereon, situate, lying and being on the Northern side of Gethserane Drive, in Greenville County, S.C., being known and designated as Lot No. 3 and the Eastern one-half of Lot No. 4, as shown on a plat of Mustang Village made by Dalton & Neves, dated June, 1967, and recorded in the RMC Office for Greenville County, S.C., in Plat Book TTT, at page 1, and having, according to a plat entitled "Revision of Lots 3-4-5 Mustang Village" made by Campbell & Clarkson, Surveyors, Inc., dated June 15, 1978, recorded in Plat Book 6-P, at page 67, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northern side of Gethserane Drive at the joint corner of Lots No. 2 and 3; and running thence along the common line of said Lots, N. 21-37 E., 115 feet to an iron pin; thence along the common line of Lots No. 1 and 3, N. 36-01 E., 135.5 feet to an iron pin; thence N. 51-50 W., 100 feet to an iron pin at the joint rear corner of Lots No. 3, 4, and 6; thence along the common line of Lots No. 4 and 6, S. 65-42 W., 73.45 feet to an iron pin; thence along a new line through Lot No. 4, S. 21-22 W., 228.6 feet to an iron pin on the Northern side of Gethserane Drive in the front line of Lot No. 4; thence along the Northern side of Gethserane Drive, S. 72-51 E., 37.5 feet to an iron pin; thence continuing with the Northern side of Gethserane Drive, S. 71-13 E., 75 feet to an iron pin, the point of beginning.
