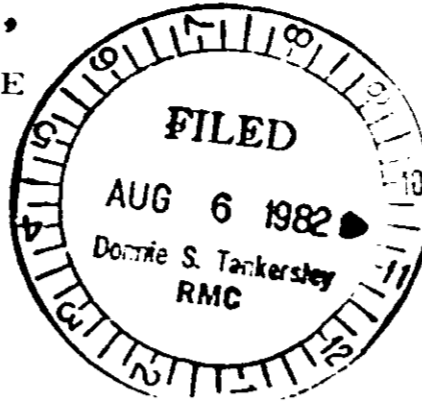
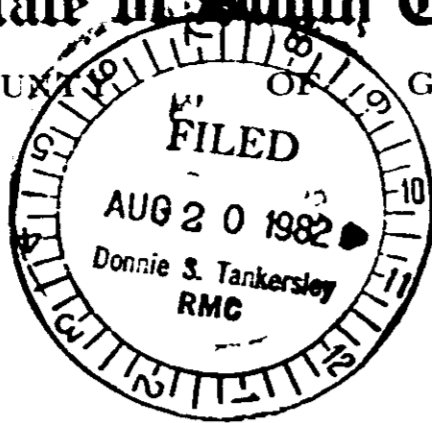

acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and
release unto the said James R. Crosby and Nancy M. Crosby, their heirs and assigns,
forever:

ALL that piece, parcel or lot of land being, lying and situate in Dunklin Township, Greenville County, S. C. and being shown and designated as Lot No. Two (2) containing 0.77 acres on plat of property survey for W. L. Cheek and Winnie D. Cheek dated August 23, 1976, by F. E. Ragsdale, R. L. S., and which plat has been recorded in the RMC office for Greenville County, S. C. and on which plat said 0.77 acres hereby conveyed is more particularly described as follows: BEGINNING at an axle O. in the Northeastern edge of right of way of U. S. Highway No. 25, said point being 37.5 ft. from the center edge of said Highway No. 25 and being the common corner with property owned by Alan O. Southern and running thence from said beginning point along said Allen D. Southern line N-54-53-E 275.0 ft. to IPO by stone; thence along the lines of other lands of Allen Southern S-43-46-E 125.0 ft. to IPN; thence along Lot No. One (1) as shown on said plat S-54-58-W 272.4 ft. to IPN at edge of U. S. Highway No. 25 right of way; thence along said U. S. Highway No. 25 N-44-58-W to the beginning axle O. corner; being bounded on the Northeast by Allen D. Southern; on the Southeast by Lot No. One (1); on the Southwest by U. S. Highway No. 25; and on the Northwest by Allen D. Southern, all as shown on said plat; being a portion of the same property conveyed unto grantors herein by deed of E. Inman as master, by deed recorded December 19, 1957, of record in Deed Book 589 at Page 431 and by deed of E. I.
