ALL my undivided one-half interest in and to the following described property:

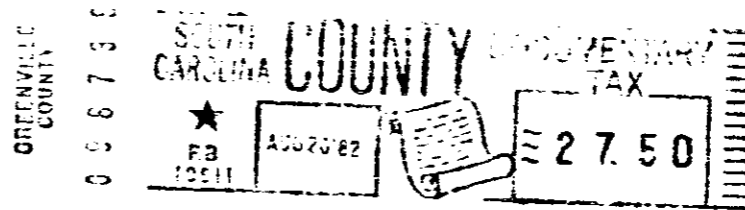
