The Grantor does hereby grant, bargain, sell and release unto the Grantee the right, privilege and easement to enter upon and exit from the property of the Grantor located at Builder Marts of America, Inc., adjacent to I-385, in Greenville County, State of South Carolina, in and through said property of the Grantor as shown on the drawing entitled "B.M.A. Realty, Inc. to Commissioners of Public Works of the City of Greenville, S.C." dated July 27, 1982, attached hereto and made a part hereof for the purpose of reading, operating, maintaining, replacing and adding to the water meters and other appurtenances thereto located on the said property of the Grantor.

It being understood that the water mains located in and serving Builder Marts of America and being on the property of the Grantor, shall be and do remain the property of the Grantor and the Grantor shall be fully responsible for the maintenance thereof.
