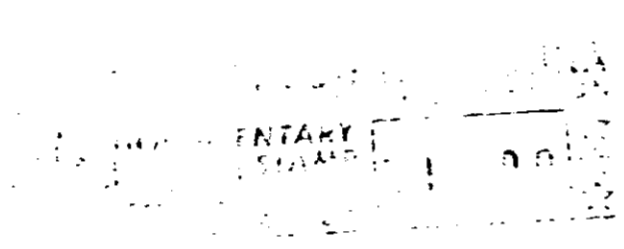
KNOW ALL MEN BY THESE PRESENTS, that McClimon & Hill, Inc.
