the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto WILLIAM M. MARTIN and ANN H. MARTIN, their heirs and assigns forever:

ALL that certain piece, parcel or lot of land situate, lying and being on the south side of East Stone Avenue in the City of Greenville, County of Greenville, State of South Carolina, known and designated as Lot No. 27 of Section H of the Stone Land Company, as shown on plat recorded in the RMC Office for Greenville County, S.C., in Plat Book A at Pages 337-345, and also as shown on plat recorded in the RMC Office for Greenville County, S.C., in Plat Book K at Pages 277 and 278.
