KNOW ALL MEN BY THESE PRESENTS, that Laurel Woods Apartments, Phase 1, A South Carolina General Partnership having its principal place of business at 23999 West Ten Mile Road, Southfield, Michigan 48034, in consideration of One and no/100 (\$1.00) Dollars, the receipt of which is hereby acknowledged, does hereby grant and convey unto the COMMISSIONERS OF PUBLIC WORKS OF THE CITY OF GREENVILLE, SOUTH CAROLINA, their successors and assigns forever the right, privilege and easement to enter upon the property of the Grantor located adjacent to and westerly of Fairforest Way, between Cavalier Drive and Wenwood Road, in Greenville County, State of South Carolina, as shown on the drawing entitled "Laurel Woods Apartments, Phase 1, A South Carolina General Partnership, to Commissioners of Public Works of the City of Greenville, S.C." dated August 13, 1982, attached hereto and made a part hereof, for the purpose of reading, operating, maintaining, replacing and adding to the water meters and other appurtenances thereto located on the said property of the Grantor.

It being understood that the water mains located in and serving Laurel Woods Apartments, Phase 1, and being on the property of the Grantor shall be and do remain the property of the Grantor and the Grantor or its successors shall be fully responsible for the maintenance thereof.
