Fifty-nine Thousand, Five Hundred and No/100 (\$59,500.00) Dollars,

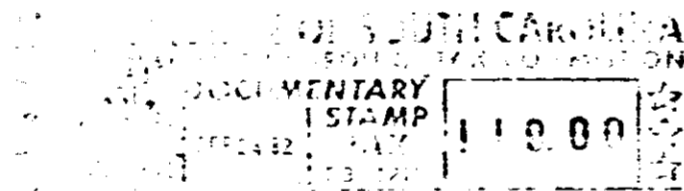
