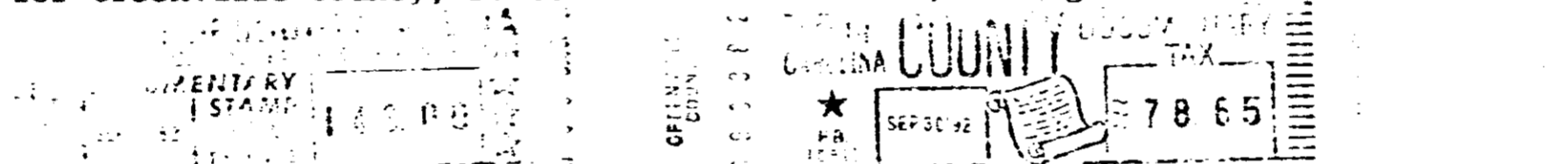
John R. Vann, his heirs and assigns, forever:
