All that certain piece, parcel or lot of land, with the buildings and improvements thereon, lying and being on the Northwesterly side of Hunting Hill Circle, near the City of Greenville, South Carolina, being known and designated as Lot No. 520 on plat entitled "Map 4, Section 2, Sugar Creek", as recorded in the R.M.C. BEGINNING at an iron pin on the Northwesterly side of Hunting Hill Circle, said pin being the joint front corner of Lots 519 and 520, and running thence with the common line of said lots N. 26-27-26 W. 227.42 feet to an iron pin at the joint rear corner of Lots 519 and 520; thence S. 29-25 W. 21.68 feet to an iron pin; thence S. 31-10 W. 121.86 feet to an iron pin at the joint rear corner of Lots 520 and 521; thence with the common line of said lots S. 42-38-43 E. 167.19 feet to an iron pin on the northwesterly side of Hunting Hill Circle; thence with the northwesterly side of Hunting Hill Circle on a curve, the chord of which is N. 55-26-55 E. 75 feet to an iron pin at the point of beginning.
