COMMISSIONERS OF PUBLIC WORKS OF THE CITY OF GREENVILLE, SOUTH CAROLINA, their successors and assigns forever:

ALL water mains, lines, valves and appurtenances installed and located in Sugar Creek (Map 1, Sec. 3), in Greenville County, State of South Carolina, including 1,180 feet, more or less, of 8" D.I. Pipe; 1,435 feet, more or less, of 6" D.I. Pipe; 1,340 feet, more or less, of 2" Galv. Pipe; one (1) 8" valve; six (6) 6" valves; twelve (12) 2" valves; three (3) fire hydrants; and nineteen (19) valve boxes as shown on a drawing entitled "John C. Cothran Co., Inc., Ellis L. Darby, Jr. and M. Graham Profitt, III to Commissioners of Public Works of the City of Greenville, S.C." dated November 9, 1982, attached hereto and made a part of this conveyance.
