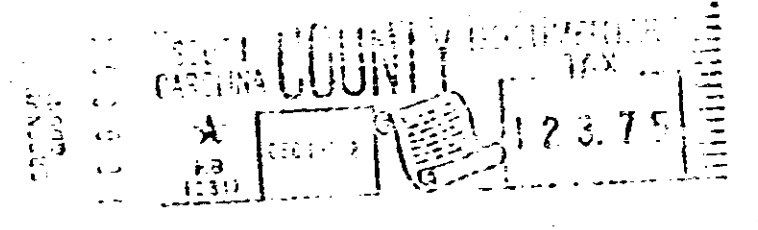
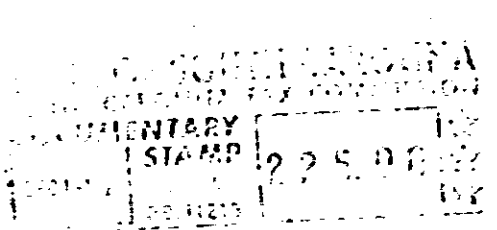

BEGINNING at an iron pin on the westerly side of Ladyslipper Lane, said pin being the joint front corner of Lots 515 and 516, and running thence with the common line of said lots S. 72-54-30 W. 103.15 feet to an iron pin at the joint rear corner of Lots 515 and 516; thence N. 53-08-35 W. 121.56 feet to an iron pin at the joint rear corner of Lots 514 and 515; thence with the common line of said lots N. 76-38-46 E. 169.19 feet to an iron pin on the westerly side of Ladyslipper Lane; thence with the westerly side of Ladyslipper Lane on a curve, the chord of which is S. 29-42-17 E., 35.36 feet to an iron pin; thence continuing with Ladyslipper Lane S. 15-03-47 E. 52.78 feet to an iron pin at the point of beginning.
