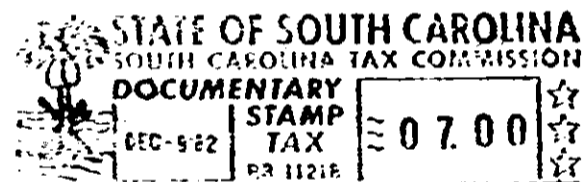
Barbara J. Carter, her heirs and assigns forever:
