the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Clayton Willimon Looper, his heirs and assigns forever:

ALL OF MY INTEREST IN AND TO:

ALL that certain parcel of land located in the State of South Carolina, County of Greenville, near the City of Greenville, on the southeastern side of Ridge Road, containing approximately 4.25 acres as shown on a plat of Property of Clayton W. Looper prepared by Century Land Surveying Company, dated January 10, 1979, and recorded in the RMC Office for Greenville County in Plat Book 6Z, at Page 5, and according to said plat, having the following courses and distances, to-wit:

BEGINNING at an iron pin on the southeastern side of Ridge Road at a point approximately 539.1 feet from the intersection of Ridge Road and Farris Bridge Road at the joint front corner of property now or formerly of J.L. Dean and the within property, and running along Ridge Road N. 27-55 E. 142 feet to an iron pin; thence continuing N. 30-52 E. 293.98 feet to an iron pin, the joint front corner of the within property now or formerly of Eugene Looper; thence running with the common line of such property S. 61-46 E. 417.81 feet to an iron pin; thence S. 27-11 W. 425 feet to an iron pin; thence N. 63-11 W. 438.46 feet to an iron pin, the point of beginning.

This is the same property conveyed to the Grantor herein by Deed of J. C. Looper dated August 7, 1933 and recorded in the R.M.C. Office for Greenville County, S.C. in Deed Book 115 at Page 501, recorded 1-17-79.

It is the intention of the Grantor to terminate her life estate interest in the above described property, giving the Grantee a fee simple title.

This conveyance is subject to all restrictions, setback lines, roadways, zoning ordinances, easements and rights-of-way, if any, affecting the above described property.
