ALSO: ALL that piece, parcel or lot of land in Chick Springs Township, Greenville County, SC, just outside the corporate limits of the City of Greenville, situate on the southwestern side of Apopka Avenue, being known and designated as Lot No. 43 on a plat of LEAWOOD EXTENSION (formerly Paris Piney Park), made by C.C. Jones, C.E., dated September 1, 1941, said plat being recorded in the R.M.C. Office for Greenville County, SC, in Plats Book "M", Page 35, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at a point on the southwestern side of Apopka Avenue, joint corner of Lots 43 and 44, and running thence S33-54W 150 feet; thence N56-06W 50 feet to the joint rear corner of Lots 42 and 43; thence N33-54E 150 feet to a point of Apopka Avenue; thence with Apopka Avenue S56-06E 50 feet to the point of beginning.

This being the identical property conveyed to the grantor herein by deed of Southern Plumbing & Heating Company, Inc., dated March 25, 1975, and recorded on March 26, 1975, in Deeds Book 1015, at Page 975.

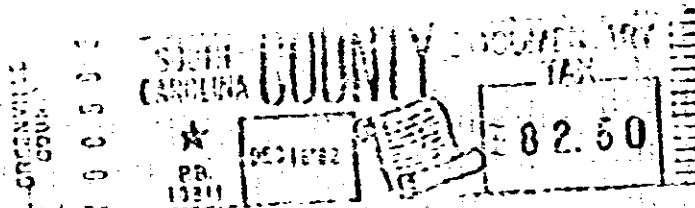
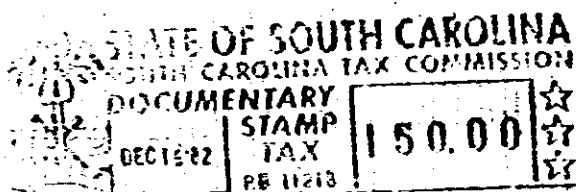

This being the identical property conveyed to the grantor herein by deed of C. & C. Enterprises, Inc. recorded in the R.M.C. Office for Greenville County, SC, in Deed Book 1048, Page 247, on December 21, 1976.

ALSO: ALL that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina, with all improvements thereon, just outside the corporate limits of the City of Greenville, situate on the south side of Apopka Avenue, being known and designated as Lot No. 37 on a plat of Leawood Extension, said plat being recorded in the Greenville County R.M.C. Office in Plat Book "M" Page 35, and having, according to said plat, the following metes and bounds, to wit:

BEGINNING at an iron pin on the southwestern side of Apopka Avenue, joint corner of Lots 37 and 38, and running along the joint line of said lots S33-54W 150 feet to an iron pin at the joint rear corner of Lots 37 and 38; thence N56-06W 50 feet to an iron pin at the joint corner of Lots 36 and 37; thence N33-54E along the joint line of Lots 36 and 37 150 feet to an iron pin on the south side of Apopka Avenue; thence S56-06E 50 feet along Apopka Avenue, the point of beginning.
