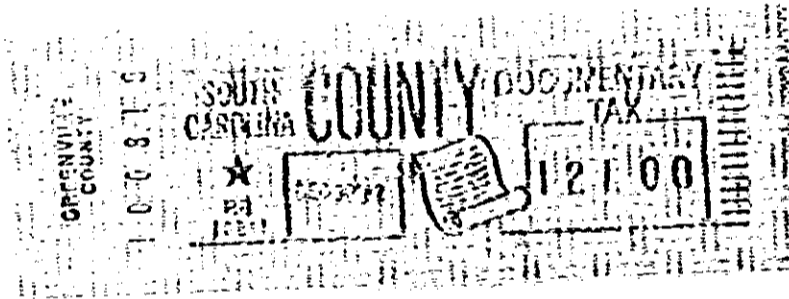
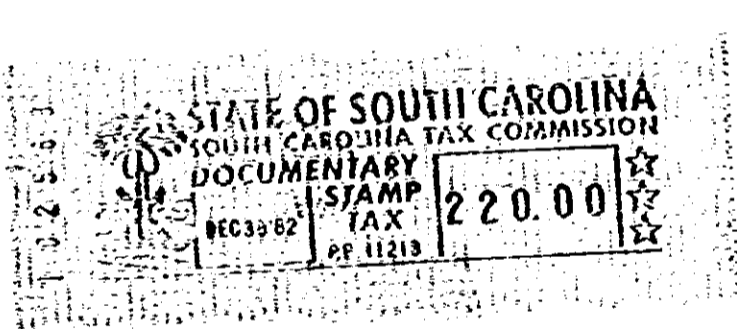

All that certain piece, parcel or lot of land, with the buildings and improvements thereon, lying and being on the northerly side of Cherrywood Trail, near the City of Greenville, South Carolina, being known and designated as Lot No. 550 on plat entitled, "Map Four, Section Two, Sugar Creek", as recorded in the R.M.C. Office for Greenville County, South Carolina, in Plat Book 8-P at Page 62, and having, according to said plat, the following metes and bounds, to-wit: 11(195) 538.17-1-42

BEGINNING at an iron pin on the northerly side of Cherrywood Trail, said pin being the joint front corner of Lots 538 and 550, and running thence with the common line of Lots 538, 539 and 550 N. 33-04-33 E. 195.67 feet to an iron pin at the joint rear corner of Lots 549 and 550; thence with the common line of said lots S. 28-30 E. 170.60 feet to an iron pin on the northerly side of Cherrywood Trail; thence with the northerly side of Cherrywood Trail on a curve, the chord of which is S. 85-44-18 W., 188.71 feet to an iron pin at the point of beginning.
