DEED CONFIRMING STREET DEDICATION

KNOW ALL MEN BY THESE PRESENTS, that the undersigned Grantors in consideration of the confirmation of an existing public street, the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto THE CITY OF TRAVELERS REST, its successors and assigns

forever:

All our right, title and interest, if any, in and to the following described property, to-wit:

ALL that lot of land in the State of South Carolina, County of Greenville, in the City of Travelers Rest, consisting of a public street known variously as Love Drive and Willis Street, measuring 30 feet in width and approximately 439 feet in length and being more specifically described as a "30 ft. street" as shown on a plat prepared by T. T. Dill, Surveyor, dated January, 1948 and recorded in the RMC Office for Greenville County in Plat Book 00 at Page 110. The subject street is also partially described on a more recent survey recorded in Plat Book 4-I at page 43.

The subject street has been opened and used by the general public for in excess of thirty years and the purpose of this deed is merely to formally confirm the dedication thereof. The undersigned grantors are the record owners of all property fronting on such street.
