

ALSO ALL that lot of land South on the South side of the Charleston and Western Carolina Railway Company and being North of the Airport Road, in the City of Greenville, in Greenville County, South Carolina, and having according to a survey made by Pickell & Pickell Engineers, May 27, 1964 revised August 17, 1964 the following metes and bounds, to-wit:

Wherry et. al. N. 10-31 W. 150 feet to an iron pin; thence still along the line of property of Jack K. Wherry et. al. N. 78-13 E. 93 feet to an iron pin; thence along the line of property formerly of C. & W C Railroad, S. 22-30 E. 160 feet to an iron pin on the North side of Lowndes Hill Road, which point is approximately 502 feet west of the center line of the C & W C.
