POWER OF ATTORNEY

KNOW ALL MEN BY THESE PRESENTS that I, C.L. Lamb, Sr. of Mauldin South Carolina, do hereby nominate, constitute and appoint my son, Charles L. Lamb, Jr. of Easley, S.C., my Attorney for me and in my name, and on my behalf to do and execute all or any of the following acts, deeds and things as fully as I might or could do if personally present, to Wit:

(1) To collect any and all money or monies due me from any source whatever and to endorse, in my name, all checks, money orders or other instruments directing the payment of money or monies to me and to cash said checks, money orders or other instruments in writing and to utilize the proceeds from said checks, money orders or other instruments as he, in his sole discretion, shall deem to be for my best use and benefit.

(2) To make, execute and deliver checks against my personal checking account for the payment of any and all of my just debts and obligations, including medical expenses, living expenses or any and all other expenses as he may deem necessary for my pleasure, comfort, use and benefit. He may also use any bank account, saving account, certificate of deposit or any of my assets for my use or for the use and benefit of my wife, Ila E. Lamb.

(3) To sell or mortgage any and all of the real and or personal property owned by me, or any interest therein; to make, execute and deliver any and all real estate deeds, mortgages, titles, bills of sales, incidental to or necessary to convey, mortgage, or sell or transfer any or all of my real or personal property.

(4) To do any and all things or deeds as he in his sole discretion may determine to be necessary or advisable for my best interest or that of my wife, Ila E. Lamb.

(5) My Attorney herein named shall not be required to account for nor to explain to any one his actions as my Attorney, as I have and do grant him the sole and exclusive power and authority to act for me in all things herein set forth.

This power of Attorney shall remain in full force and effect until such time as I may revoke same in writing and record such revocation in any such County as this Power of Attorney may be recorded.
