unto E. Richard Taylor, Jr., Karolyn K. Taylor, Earle R. Taylor, III and Charles Kendrick Taylor, their heirs and assigns, an undivided thirty-nine/hundredths (.39) interest in and to, to wit:

ALL that piece, parcel or tract of land containing Thirty-eight (38) acres, more or less, situate, lying and being on the southern side of Ansel School Road, the northeastern side of Memorial Drive Extension, and the western side of a proposed road known as Watson Road, in Chick Springs Township, Greenville County, South Carolina, being a portion of Lot 44, Block 1, on Sheet 537.4 of the Greenville County Tax Maps, and having the following metes and bounds, to-wit:

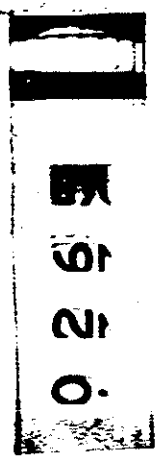
