KNOW ALL MEN BY THESE PRESENTS, that

in consideration of One and no/100 (\$1.00)-----Dollars,

the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto VIVIAN B. RICE, her heirs and assigns, forever:

An undivided one-twelfth (1/12th) interest in and to all that piece, parcel or tract of land lying north of SC Highway No. 11 which leads from US Highway 25 to Gowansville, South Carolina, in Saluda Township, Greenville County, South Carolina, containing five (5) acres, more or less, according to a survey by H. C. Clarkson dated December 28, 1965, and recorded in the RMC Office for Greenville County, SC in Plat Book MMM, at Page 15, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the North side of a private driveway leading from SC Highway No. 11 to a Lodge and running thence N24-31W, 117.4 ft. to an iron pin; thence N50-30W, 181.1 ft. to an iron pin; thence N76-58W, 183.3 ft. to an iron pin; thence S49-01W, 348.8 ft. to a point on line with property now or formerly of Trammell, which point is approximately 103 ft. in a Southerly direction from old iron pin on said line; thence S21-00W, 483.4 ft. to the North side of SC Highway No. 11 (there being an iron pin approximately 78.4 ft. on said line in a Northerly direction from the North side of said Highway at the top of bank); thence along SC Highway No. 11 the following courses and distances: N55-02E, 349.5 ft.; N58-39E, 107.2 ft.; N68-38E, 101.95 ft. and N72-25E, 233.4 ft. to a point of the North side of the said driveway leading from SC Highway No. 11 to the Lodge; thence with said driveway, N63-41E, 117.3 ft. to the point of beginning. 4-355-657.2-1-15.2-
