the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Wilson Farms Company, a general Partnership, its successors and assigns forever, all our right, title and interest, the same being an undivided 10 percent (10%) interest each in and to the following described property:

ALL that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, City of Greenville on the south side of East Washington Street and being shown as Lots 14 and 14-A and a strip of land lying between the front of Lot 14 and the south side of East Washington Street as shown on plat of property of W. C. Cleveland, recorded in the RMC Office for Greenville County in Plat Book A at Pages 470 and 471, and having, according to said plat, the following metes and bounds, to wit: 26 (500) 65-1-11
