Walter B. Townley, Jr. and Durelle T. Townley, their heirs and assigns, forever:

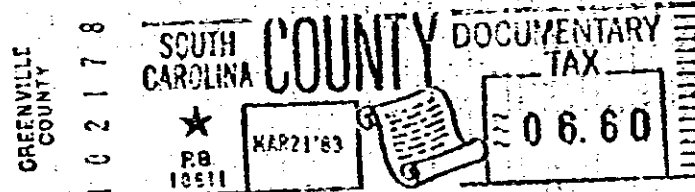
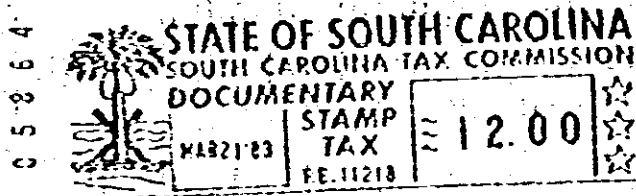
