release unto BRENT L. DILL and JEAN R. AMASON, their heirs and assigns, forever:

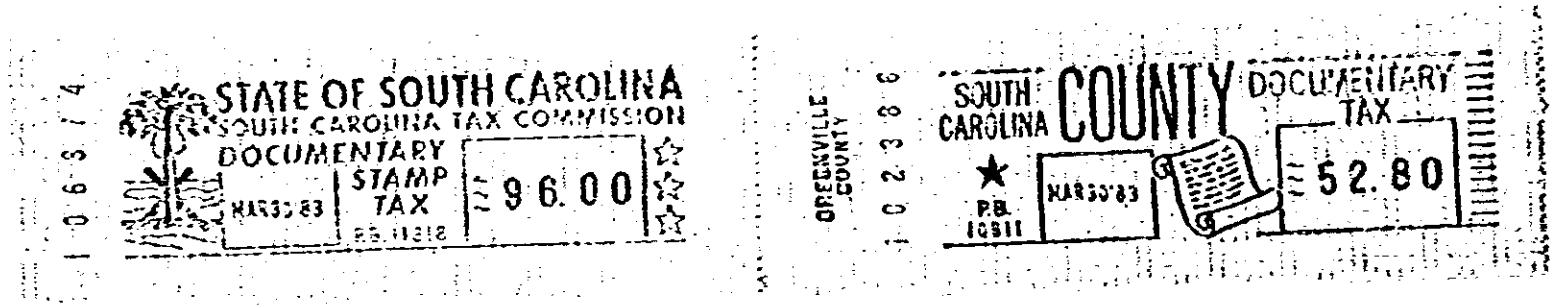
ALL that certain piece, parcel or lot of land situate, lying and being
