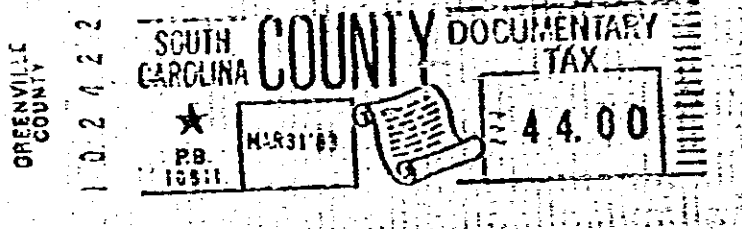
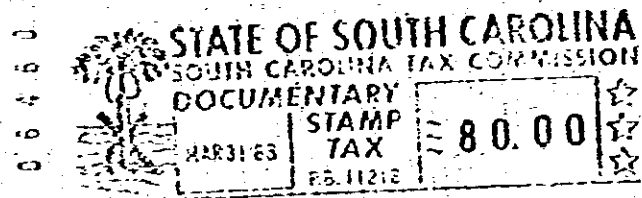
KNOW ALL MEN BY THESE PRESENTS, that SHELLEY REALTY and CONSTRUCTION COMPANY
