the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Edwin R. Newton and Sandra R. Newton, their heirs and assigns forever;

My total 1/9th undivided interest in and to the following property;

ALL that certain piece, parcel or lot of land, situate, lying and being in the State of South Carolina, County of Greenville, in Paris Mountain Township, being known and designated as Lot 33 of a subdivision known as Sunny Acres as shown on plat prepared by C. C. Jones, C.E., August 1961, recorded in the R.M.C. Office for Greenville County in Plat Book XX, at Page 5 and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southwestern side of Wildrose Lane, joint front corner of Lots 32 and 33 and running thence along the joint line of said lots, S. 33-30 W. 89.6 feet to an iron pin at the joint corner of Lots 32, 33 and 43; thence along the rear line of Lot 43, N. 75-34 W. 134.1 feet to an iron pin at the rear corner of Lot 34; thence along the line of that lot, N. 33-30 E. 129.1 feet to an iron pin on the southwestern side of Wildrose Lane; thence along the southwestern side of Wildrose Lane, S. 56-30 E. 114 feet to the beginning corner.
