in consideration of Twelve Thousand and No/100-----(\$12,000.00)-----Dollars,

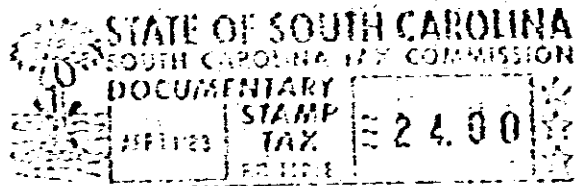
