Irwin Bittner and Sonia F. Bittner, their heirs and assigns forever:

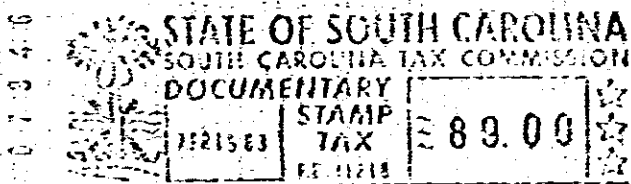
