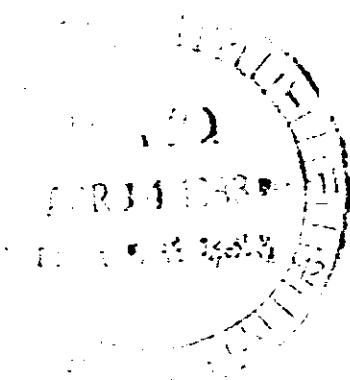
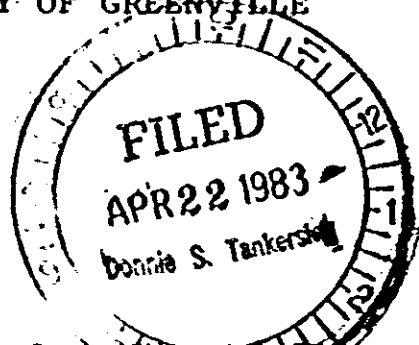

All that tract of land located in Paris Mountain Township, County of Greenville, State of South Carolina, containing 12.74 acres more or less, and shown as Tract "E" on a plat entitled "Survey for Margaret L. Gibson Estate" prepared by C.O. Riddle, Surveyor, dated June 5, 1980, and recorded in Plat Book 9-M at page 83. Said property has the following metes and bounds as shown on said plat: Beginning at a railroad spike in the center of Gibson Road on line of Joyce Martin Porter property; thence along the center of said road N 62-16 E 88.09 feet to a nail and cap; thence along center of said road N 58-19 E 102.65 feet to a nail and cap; thence along center of said road N 46-52 E 121.84 feet to a nail and cap; thence along said road N 34-37 E 118.44 feet to a nail and cap; thence along said road N 30-22 E 263.32 feet to a railroad spike at the intersection of Gibson Road and Martin Road; thence along the right of way of Martin Road S 58-35 E 300.59 feet to a point, thence along said right of way S 57-00 E 100 feet to a point; thence along said right of way S 49-10 E 100 feet to a point, thence along said right of way S 41-55 E 100 feet to an iron pin on line of Ruby Edwards Martin et al property; thence with said Martin property S 24-16 W 420.6 feet to a stone, corner of Thelma Earline Keller property; thence with said Keller property S 24-03 W 229.04 feet to an iron pin, corner of Ruby E. Martin et al property; thence with said Martin property N 74-20 W 760.61 feet to a stone, corner of Joyce Martin Porter property; thence with said Porter property N 14-30 E 242.93 feet to the beginning point.

This conveyance, the aforesaid Tract "E" in said plat, is a portion of what was Tract 2 as shown on a plat entitled "Estate of B.M. Gibson" dated October 23, 1936, by J.W. Riddle, Surveyor.
