

This conveyance, the aforesaid Tract "B" in said plat, consists primarily of what was Tract 2 as shown on a plat entitled "Estate of B.M. Gibson" dated October 23, 1936, by W.J. Riddle, Surveyor. Approximately 45.7 acres of the 47.1 acres of Tract 2 as shown on said plat was conveyed to B.M. Gibson, father of the grantor and grantee herein from Ida G. Leopard by way of Deed dated December 31, 1951, and recorded in the R.M.C. Office for Greenville County, S.C. in Book 448 at page 228. The portion of Tract 2 not conveyed to the said B.M. Gibson was an eastern corner of Tract 2 whereon stood the residence of the said Ida Gibson Leopard. The eastern strip of Tract "B" (as shown on survey for Margaret L. Gibson Estate) is derived from a purchase by B.M. Gibson from Lucille C. Morris, said Deed dated July 25, 1957, and recorded in the R.M.C. Office for Greenville County, S.C. in Book 581 at page 40. The portion of Tract 2 as shown on the Estate of B.M. Gibson which is to be excluded from Tract "B" are as follows: First, that portion sold by B.M. Gibson to H.C. Batson located in the western section of the said Tract 2. This 5.0 acre tract is more precisely shown on a plat entitled "Property of H.C. Batson" dated October 14, 1961, by J.C. Hill, L.S. Second, an 8.0 acre conveyance by B.M. Gibson to the Greenville County School system, said conveyance occurring on or about August of 1963. The property so conveyed to the Greenville County School system is shown more precisely by a plat entitled "Property of B.M. Gibson" near Greenville, S.C. dated August 29, 1963, by Piedmont Engineers and Architects. Third, that portion of Tract 2 in the plat entitled "Estate of B.M. Gibson" which is also excluded from the subject Tract "B" is any portion of the survey for Margaret L. Gibson Estate designated as Tracts "C", "D", and "E". The remainder of Tract "B" which is not part of the original Tract 2 (as shown on plat entitled "Estate of B.M. Gibson") derives from the southern boundary of Tract 1 as shown on plat entitled "Estate of B.M. Gibson". All of the aforesaid property was inherited by Margaret L. Gibson from her husband, father of grantor and grantee herein. In turn, the aforesaid property was inherited from the said Margaret L. Gibson by the grantor and grantee herein. The Will of said Margaret L. Gibson was presented in common form before the Probate Court for Greenville County, S.C. and is filed in the records of said Court.
