BEGINNING at an iron pin near a water line and running thence S. 28-15 W. 278 feet to a point; thence running S. 37-30 W. 115 feet to a point; thence running S. 62 W. 231 feet to a red Oak; thence running S. 59-45 W. 252 feet to a point; thence running S. 87 W. 94 feet to a Spanish Oak; thence running N. 59 W. 128 feet to a small pine; thence running N. 33-45 W. 176 feet to a point; thence running N. 28 W. 212 feet to a point; thence running N. 1-30 E. 161 feet to a point; thence running N. 3-15 W. 199 feet to a point; thence running N. 30 W. 209 feet to the Goldsmith line; thence running S. 82-45 E. 215 feet to an iron pin; thence running S. 70 E. 90 feet to a black gum; thence running S. 89-30 E. 132 feet to a point; thence running S. 62-40 E. 710 feet to an iron pin, the point of beginning.
