the receipt of which is hereby acknowledged, have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto Larry Hall and Shirley R. Hall, their heirs and assigns forever:

"ALL that certain piece, parcel or lot of land, situate, lying and being in the State of South Carolina, County of Greenville on waters of Mathers Creek, in the 'Sunset Valley Subdivision,' Block A, being shown and designated as Lot No. 2 on Plat of John C. Smith, Surveyor, dated July, 1960, Plat Book WW, at pages 112 and 113 and being more particularly described according to said plat as follows, to-wit:
