

10. To borrow any sum or sums of money on such terms and with such security, whether real or personal property, as she shall think fit, and, for that purpose, to execute all notes, bonds, mortgages, pledges, and other instruments that may be necessary or proper.

11. To sign, seal, execute, and deliver any and all contracts, agreements, deeds, and other instruments whatsoever, and acknowledge the same, and to make, draw, sign, endorse, accept, discount, and otherwise deal with, checks, notes, bills, drafts, and other commercial and mercantile paper, in execution of any and all powers hereby conferred.

12. To do in general and without exception, limitation, qualification or restriction any and all other deeds, acts, and things whatsoever in or about my estate, property, and affairs and to concur with any other person or persons jointly interested with me therein in doing any and all such deeds, acts, and things as fully and as effectually to all intents and purposes as I, myself, in my own proper person could personally do.

13. To appoint and remove at pleasure any substitute for or agent under her in respect of all or any of the matters and things aforesaid upon such terms as she shall think fit.

14. And I, the said Harland D. Glenn do hereby ratify and confirm and promise at all times to ratify and confirm all and singular whatsoever my said attorney shall do or cause to be done in or about the premises by virtue of these presents.

15. This Power of Attorney shall not be affected by physical disability or mental incompetence of the principal which renders the principal incapable of managing his own estate.
