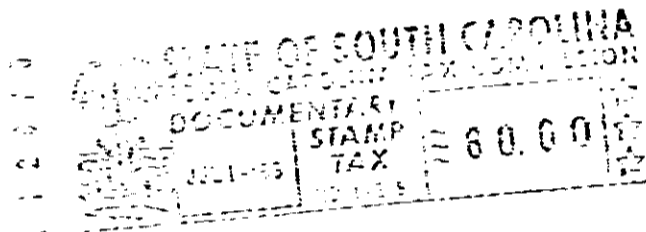
in consideration of Thirty Thousand and no/100 (\$30,000.00) Dollars,
