release unto Premier Investment Co., Inc., its successors or assigns, forever:

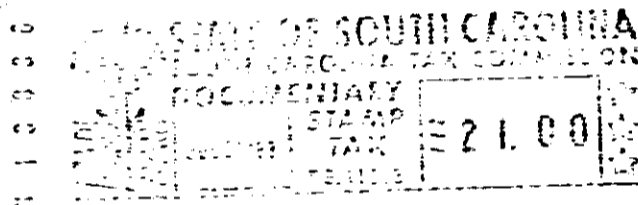
