All that certain piece, parcel or lot of land with the buildings and improvements thereon, lying and being on the easterly side of Ladyslipper Lane, near the City of Greenville, South Carolina, being known and designated as Lot No. 574 on plat entitled "Map 4, Section 2, Sugar Creek", as recorded in the RMC Office for Greenville County, S. C. in Plat Book 8-P at page 62, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the easterly side of Ladyslipper Lane, said pin being the joint front corner of Lots 574 and 575 and running thence with the common line of said lots S. 81-36-27 E. 143.69 feet to an iron pin, the joint rear corner of Lots 574 and 575; thence S. 07-27-13 W. 85.43 feet to an iron pin, the joint rear corner of Lots 573 and 574; thence with the common line of said lots N. 79-20 W. 148 feet to an iron pin on the easterly side of Ladyslipper Lane; thence with the easterly side of Ladyslipper Lane N. 10-40 E. 61 feet to an iron pin; thence continuing with said Lane N. 9-31-45 E. 18.6 feet to an iron pin, the point of beginning.
