This is a part of that tract described in the deed from J. T. Vaughan to Martha E. Harrison as tract No. 3 of the John Vaughan Tract as shown on a deed dated December 1, 1908, recorded in RMC office in deed Book 222, page 408, wherein the metes and bounds are given but excepted from said description is a tract of (11) eleven acres conveyed by Martha E. Harrison to W. A. Smith by deed recorded in Deed Book 17, page 129, in said RMC office, reference to said deed for J. T. Vaughan to Martha E. Harrison is hereby craved for a full description of said land less the said eleven acres.

Being the same property conveyed to J. D. Green, Jr. and Parie Jones Green by Deed of C. W. and Florine F. Bishop said Deed being dated April 28, 1956, and recorded in the office of the RMC for Greenville County in Deed Book 551 at Page 202.

ALSO, ALL that piece, parcel or lot of land in Butler Township, Greenville County, State of South Carolina, on the Scuffletown Road, about five (5) miles Southeast of Greenville and having the following metes and bounds, to-wit;

BEGINNING at a pin on the Northern edge of the said Scuffletown Road or Woodruff Road opposite Conyers and Gower property, said pin being the corner of Lizzie Griffith's land and running thence along the line of said Lizzie Griffith's land N. 16-45 W. 871 feet to an iron pin; thence S. 70-30 W. 200 feet to an iron pin at a ditch; thence S. 16-45 E. 779 feet to an iron pin on the Northern bank of said Scuffletown Road; thence along said road S. 83-45 E. 220 feet to the beginning point and containing 3.78 acres, more or less.

Being the same property conveyed to J. D. Green, Jr. and Parie Lee Green by Deed of W. Roscoe Jones, Administrator of the Estate of Grady N. Griffith, deceased, said Deed being recorded in the office of the RMC for Greenville County on January 3, 1956, in Deed Book 542 at Page 153.

The said Parie Jones Green died testate December 17, 1982. This Deed is made as a disclaimer to the property hereinabove described. Reference is hereby made to the records of the Greenville County Probate Court Apt. 1737 at File 3.

TOGETHER with all and singular the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the premises before mentioned unto the said Gerald Huskamp as Trustee under the Will of Parie Jones Green, deceased, his

heirs and assigns forever.

AND I do hereby bind myself and my heirs, executors and administrators, to warrant and forever defend all and singular the said premises unto the said

Gerald Huskamp as Trustee under the Will of Parie Jones Green, deceased, his

heirs and assigns against myself and my heirs and every other person whomsoever lawfully claiming, or to claim the same or any part thereof.
