All that piece, parcel or lot of land in the City of Greenville, County of Greenville, State of South Carolina, being shown and designated as all of Lot 25 and a portion of Lot 26 on plat of property of Augusta Park, property of M. C. Westervelt, Trustee, Addition to Greenville County, South Carolina, recorded in Plat Book F, Pages 22 and 23 in the R.M.C. Office for Greenville County and being more particularly described as Lot 25 on a survey shown as a Revision of Lots 25, 26, 27 and 28 Augusta Circle prepared by Clifford C. Jones, dated July 15, 1980, and having, according to this more recent survey, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Waccamaw Avenue at the joint corner of Lots 24 and 25 and running along the common line of said Lots S. 71-35 E., 166.3 feet to an iron pin; thence along the rear of Lot 25 S. 21-35 W., 66.66 feet to an iron pin at the joint corner of Lots 25 and 26; thence along the common line of Lots 25 and 26 N. 71-35 W., 166.3 feet to an iron pin on the eastern side of Waccamaw Avenue; thence along the eastern side of Waccamaw Avenue N. 21-35 E., 66.66 feet to an iron pin, being the point of beginning.
